Mr. David Johnson called the meeting to order.

Mr. David Johnson called for a motion to approve the minutes of the December 12, 2023, meeting if no changes were needed. Mr. Mickey Yates made the motion to accept the minutes as presented. The motion was seconded by Mr. Daniel Jordan and passed with none opposed.

Ms. Tina Wells presented the Portal Highlights and Current Projects portion of the EOC reports:

- The Mississippi State Personnel Board (MSPB) and Tyler met to discuss a new website for their Employee Appeals Board (EAB). Tyler provided a comprehensive demonstration of the Magnolia Template, including content creation, management, and migration.
- The Mississippi Athletic Commission (MAC), in partnership with Tyler, launched the Athletic Commission Licensing Application. This suite of services provides users and the agency with a singular access point to complete and manage applications for Promotor Licenses, Event Permits, and Combatant Sports Licenses. This service was developed under the self-funded model at no cost to the agency and allowed MAC to realize a cost avoidance of over \$45,000 worth of development, design, and project management services.
- In October, the Mississippi Forestry Commission (MFC) launched the MFC Burn Permit Application. Previously a paper-based process, the online application provides citizens the ability to apply for and document approved burning throughout the state.
- This month, Tyler launched a custom website for the Pearl River Valley Water Supply District (PRV). The updated design highlights new photo galleries of the Ross Barnett Reservoir, enhanced news, and events calendar functions, as well as a new comprehensive Parks & Recreation section. The website redesign provided PRV with a

cost avoidance of more than \$30,000 in design, development, and project management services.

- Tyler and the Mississippi Department of Rehabilitation Services (MDRS) launched the
  Office of Special Disability Programs Referral application in October. This new service
  converted the existing PDF application into an accessible online form. The Office of
  Special Disability Programs Referral application was developed at no cost to MDRS and
  provided \$15,000 in cost savings to the agency.
- Following the launch of the Office of Special Disability Programs Referral Form, MDRS
  reached out to explore the development of an Online Procurement Application. This new
  application will establish a digital workflow for the agency, streamlining the distribution,
  acceptance, and approval of projects among the agency's approved vendors. The system
  will also enhance transparency, ensuring vendors are informed of potential opportunities
  and clearly understand bid procedures.
- The East Mississippi State Hospital (EMSH) approached Tyler looking for a solution to modernize their payment processes. EMSH currently collects paper applications and invoices for Health Records Requests, Nursing Home Payments, and Group Home Payments, resulting in a time-consuming and resource-intensive process. Tyler met with the agency in November to discuss various payment options and online application solutions that could fit EMSH's needs.
- In October, the Mississippi eGovernment program saw its 400th service launched into production.
- Mississippi's Official Website, ms.gov, was named a gold award winner in the 2023 w3 Awards competition and the 2023 Davey Awards competition.
- The following services received MarCom Awards for their use of design and citizen experience:
  - o Gold Winner Mississippi Department of Corrections Website
  - Silver Winner MEMA Mobile App
- In November, Tyler met with the Mississippi Department of Wildlife, Fisheries and Parks (MDWFP) to discuss the implementation of an online Quail Hunting Survey. The new survey will provide state biologists with valuable feedback from Mississippi hunters as they work to assess the health of Mississippi gamebirds and their habitats.
- In November, Tyler and the Department of Revenue (DOR) launched the Alcoholic Beverage Control (ABC) Mobile Inspection Application by leveraging Tyler's OntheGo (OTG) platform. Inspectors can now complete inspections directly from their mobile device, regardless of wireless connectivity, and inspection data automatically syncs with the DOR database once the agent is back within Wi-Fi range.
- Additionally, Tyler worked with DOR to enhance the Mississippi Tax QuickPay
  application by adding three new tax payment types. These new options allow businesses
  and individuals to quickly and securely pay their Mississippi taxes using a credit card,
  debit card, or eCheck for any of the 23 available tax payment types. Since the
  application's launch in 2019, Tyler has successfully processed more than \$166 million in
  revenue for DOR through this service.
- The Mississippi Highway Patrol (MHP) receives up to 150 manual requests each month
  for full resolution crash report photos. To decrease this manual process, the Mississippi
  Department of Public Safety (DPS) asked Tyler to implement new functionality within the
  DPS eCrash Report system that would provide customers the option to electronically
  purchase full resolution photo files.
- Tyler and the Mississippi State Department of Health (MSDH) recently met to discuss enhancements to the existing Childcare Facility Mobile Inspection Application. The new functionality will broaden the scope of the current inspection process to include follow-ups,

youth camps, residential, and unlicensed facility inspections and will allow the agency to digitally complete an additional 2,000 annual inspections.

Ms. Wells presented the fiscal reports covering activities since the last meeting and fiscal year-to-date transactional metrics.

Ms. Wells discussed the status of projects in development and presented the following projects for Prioritization Approval:
